THESE VISITORS ENJOY AND LEARN ABOUT THE AQUARIUM'S 20,000 AQUATIC PLANT AND MARINE FISH AND ANIMAL RESIDENTS THROUGH SELF-GUIDED TOURS AND GALLERY INTERPRETERS. THIS EXPERIENCE PROVIDES AN EYE-OPENING WINDOW INTO LIFE BELOW THE SURFACE. THE MOST SIGNIFICANT ACCOMPLISHMENT IN FISCAL YEAR 2013 RELATES TO THE COLLABORATION EFFORTS BETWEEN THE AQUARIUM, FLORIDA FISH AND WILDLIFE CONSERVATION COMMISSION (FWC), AND TAMPA ELECTRIC COMPANY (TECO). THESE 3 PARTIES HAVE COME TOGETHER TO CREATE A "FLORIDA CONSERVATION & TECHNOLOGY CENTER" ON LAND ADJACENT TO TECO'S MANATEE VIEWING CENTER.
